



RELEASE WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT

Whereas, in consideration of being permitted to use SAWMILL Complex or attend a course of instruction involving the utilization of firearms, for use on premises and for other good and valuable consideration the receipt sufficiency of which is hereby acknowledged, Undersigned agrees to the following:

1. Undersigned agrees to indemnify, hold harmless and defend Dominus LLC and The SAWMILL Tactical Training Complex, LLC and or its instructors or staff from any and all fault, liabilities, costs, expenses, claims, demands, or lawsuits arising out of, related to or connected with: Undersigned presence at THE SAWMILL and/or participation in the course of instruction; the discharge of firearms by Undersigned. Undersigned presence on or use of the range, buildings, land and premises (Premises"); and, any and all acts or omissions of Undersigned.
2. Undersigned furthermore, waives for himself/herself and for his/her executors, personal representatives, administrators, assignees, heirs and next of kin, any and all rights and claim for damages, loses, demands and any other actions or claims whatsoever, which he/she may have or which may arise against DOMINUS, LLC or THE SAWMILL and/or its instructors and staff including but not limited to the death of undersigned and/or any and all injuries, damages or illnesses suffered by Undersigned or arise out of, be related to or be connected with: the course of instruction: the premises: Undersigned's property (whether or not entrusted to instructor); and, the discharge of firearms. DOMINUS, LLC and/or THE SAWMILL and/or its instructors and staff shall not be liable for, and undersigned, on behalf of himself/herself and on behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases DOMINUS, LLC and/or its instructors and staff from any and all such claims and liabilities.
3. Undersigned hereby expressly assumes the risk of taking part in the course for instruction in firearms and taking part in the activities on the premises, which include but are not limited to, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition
4. Undersigned acknowledges and agrees that Undersigned had read this instrument and understands its terms and is executing this instrument voluntarily. Undersigned furthermore hereby acknowledges and agrees that he/she had read, understands and will at all times abide by all range rules and procedures and any other rules and procedures stated by the instructor.
5. Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of the instrument is intended to be of exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by DOMINUS, LLC shall not constitute any waiver of DOMINUS, LLC, THE SAWMILL and/or its instructor's or staff's right to pursue any other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin period.
